
## My 544 Days in an Iranian Prison: Solitary Confinement, Sham Trial, High Stakes

On November 26, 2020, I was finally brought to trial. The charges against me were espionage and "spreading propaganda against the Islamic Republic." The trial was a sham. The evidence against me was fabricated, and the judge was clearly biased against me. I was convicted and sentenced to 10 years in prison.

I was released from prison on January 16, 2023, after the Iranian government agreed to a prisoner swap with the United States. The swap was negotiated by the Biden administration, and it included the release of four other American prisoners.

My time in Iranian prison was a harrowing experience. I was subjected to physical and psychological torture, and I was denied access to a lawyer and my family. #### **Solitary Confinement**

The trial was a complete miscarriage of justice. I was convicted and sentenced to 10 years in prison for a crime that I did not commit.


#### **High Stakes**


