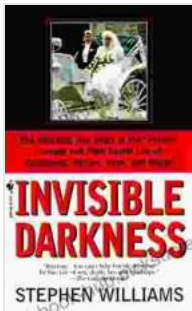

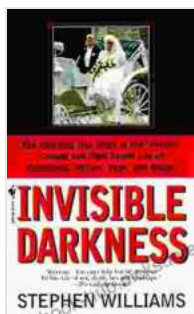
### **The Aftermath**
